8. Earnest Money Deposit:

- 9. In view of The Bihar Finance (Amendment) Rule 2005, Rule 1310 related to EMD, the agency has to deposit bid security of Rs. 5,000/- in the form of demand draft or the agency must submit request for exemption from submission of bid security under relevant rule.
- 10. Performance Guarantee: In accordance with The Bihar Finance (Amendment) Rule 2005, Rule 131P related to Performance Security, the successful bidder shall be required to submit a performance guarantee equivalent to five percent of the contract value (in rupees) rounded off to the nearest 100 rupees within a week of the issue of Acceptance of Bid letter by the Board.
